Sri Padmanabhaiah delivered the "Bankatlal Badruka Endowment Lecture" on "Impact of BREXIT on Indian Economy". He explained, at length, the circumstances that led to the Exit of Britain from the European Economic Union and resultant effects on UK economy as well as that of other European Union Members like Germany, France and countries like USA, India etc. India needs to arrive at fresh Free Trade Agreements with all these countries. Since the Brexit is going to be spread over the next 2 to 3 years, in a phased manner, he felt that the Exit may not pose a problem, to the growth of Indian Economy.

Sri Padmanabhaiah garu was of the view that, since the economic fundamentals of India are very strong, in the long run, the Exit impact on India would be minimal. India needs to strengthen and expand its domestic trade, leverage on technology and automation, utilizing the nation's younger generation and focus on Services Sector.

He suggested that, India needs to achieve, both Universal and Digital literacy, among its huge population, to participate in the future trade revolution. Prime Minister, Sri Narendra Modi's "MAKE IN INDIA" initiative, is the right move in achieving this goal. In the economic front, India needs to match and even surpass China, utilizing our English language proficiency and age advantage of the younger generation.
