

The Academic Advisers will conduct Academic Audit as per the dates mentioned in the annexure and the Academic Audit report will be prepared and submitted to the Principals on the same day of conduct of Academic Audit under acknowledgement. Academic Advisers are requested to send a copy of same Academic Audit report in hard and soft copies to this office on the same day.

The Principals of the Colleges, concerned have to submit the Action Taken Report (ATR) within ten days from date of conduct of Academic audit to the undersigned and a soft copy to academicaudit.tgce@gmail.com without fail. The Principals of the colleges scheduled for audit have to make all necessary arrangements by updating all the records and make hospitality arrangements to the Academic Advisers.

The Academic advisers are instructed to verify records of the conduct of classes on Foundation course in Human Values and Professional Ethics, Science and Civilization, Indian Heritage and culture and Environmental Science etc. and UGC funds utilization in addition to the regular Academic records. In Pvt. Aided Colleges they are instructed to verify records pertaining to financial aspects too.

The Principals are instructed to relieve the Academic Advisers mentioned in the annexure with instructions to report at the colleges allotted to them without fail. **Further it is instructed that the Parent College shall pay T.A./D.A. to the Academic Advisers from their college funds.**
